Race Officials are using a web-based program to assist with the management of this regatta. It provides electronic forms for such actions as scoring inquiries, protests, equipment substitutions, etc. And it provides for electronic communication with competitors if competitors have provided an email and/or telephone number accepting SMS. Competitors will be notified electronically of protest time limits, confirmation of a protest filing, scheduled hearing times, etc. This electronic system allows competitors to move freely about the event and remain in contact with relevant officials. And all competitors have electronic access to the scoring inquiries, jury decisions, etc.\*

#### 1. GENERAL INFORMATION

- 1.1. Race Office will be set at the Anthaven Hotel Marina facilities.
- 1.2. The sunset time for this Race will be 1820 (local time). (ref:NoR/art1.5)

#### 2. REGISTRATION

- 2.1. J/70 class boats wishing to participate in the race shall make their registrations from the following web pages.

- 2.2. The fully completed Registration Form (Appendix-A) and all documents listed in NoR regarding registration must be send to <a href="http://ticows.com/">http://ticows.com/</a> on 16 January 2025, no later than 1700hrs (local). (ref:NoR/art6.2)
- 2.3. Crew List must be submitted to the Race Office with a wet signature during check-in.
- 2.4. In the absence of any of the above, the entry will not be considered valid.
- 2.5. Online Registration will close at 1300 (local) on Wednesday 15 January 2025.

## 3. ENTRY FEES

- 3.1. Registration and other fees are;
- 3.1.(a) Registration fee is EUR600 per boat. (TYF contribution is included in this fee.)
- 3.1.(b) The annual membership fee of the 2025 J/70 Turkish Class Association is 25.000TL.
- 3.1.(c) However, a boat participating in only one leg and not wishing to pay the annual fee shall pay a Class Association fee of 6.000TL per race.
- 3.1.(d) All entry fees are payable to the Tenzor Sailing Club by credit card or by bank transfer. Please ensure the payment reference contains: "team / boat name / sail number".

- 3.2. Payment can also be done on site, during registration confirmation, by cash or credit/debit card and must be transferred to this account with explanation before registration.

#### 4. **CREW LIMITATION**

- 4.1. Only TSF licensed sailors can participate in this race. These prescriptions shall not apply to foreign competitors.
- 4.2. Each boat owner/responsible will provide a crew list along with the registration form Appendix-A. Detection of a competitor on the boat who is not on the crew list or who is not on the boat although his name is on the list may be grounds for disqualification (DSQ) by the Protest Committee.
- 4.3. Every change of a crewmember shall be declared to the Race Office no later than two (2) hours before the scheduled time of the first warning signal of the day. Crew substitution shall be done from Official Online Notice Board. (NP)(DP)
- 4.4. The boat owner or his/her appointed official is responsible for the behaviour and conduct of all team members who register for the races at the race area and accommodation facility and for any social media (including whatsapp group for race information) posts related to the races. In case of any possible inappropriate behavior and/or social media posts/messages, upon the request of the RC, the IJ may impose a penalty, including disqualification, on the boat owner/responsible person together with the person concerned.

## 5. FORMAT AND PROGRAM OF THE RACES (ref: NoR/art.10)

- 5.1. All competing boats have bow number and sail number required by TCA
- 5.2. The RC will lay a mark for practice 16 January from 1530 to 1730 hrs(local)
- 5.3. The Skippers' briefing will be held on each Race Day at 1000 at the event area.
- 5.4. RC will endeavor to run a total of Nine (9) races at 17-18 & 19 January 2025. (Nor10.2)
- 5.5. On each race day, the warning signal time for the first race of the day will be **1200 hrs (local)**
- 5.6. The starts will be made in accordance with RRS26 (5 minutes-4 minutes-1 minutes START).
- 5.7. No warning signs will be given after 1500, 19 January 2025, on the last day of the races.
